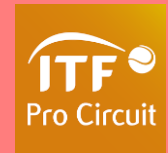

- Engaged with betting regulator

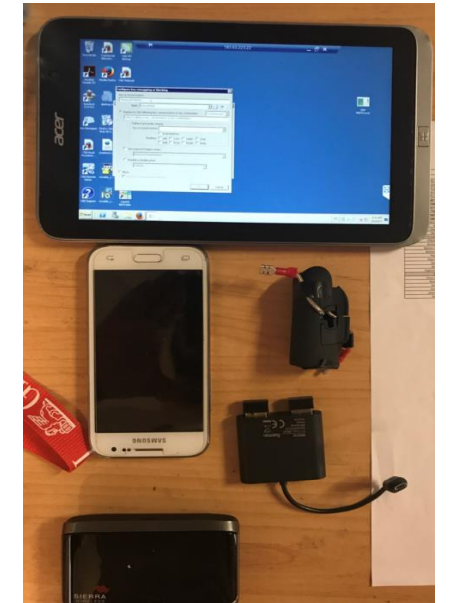
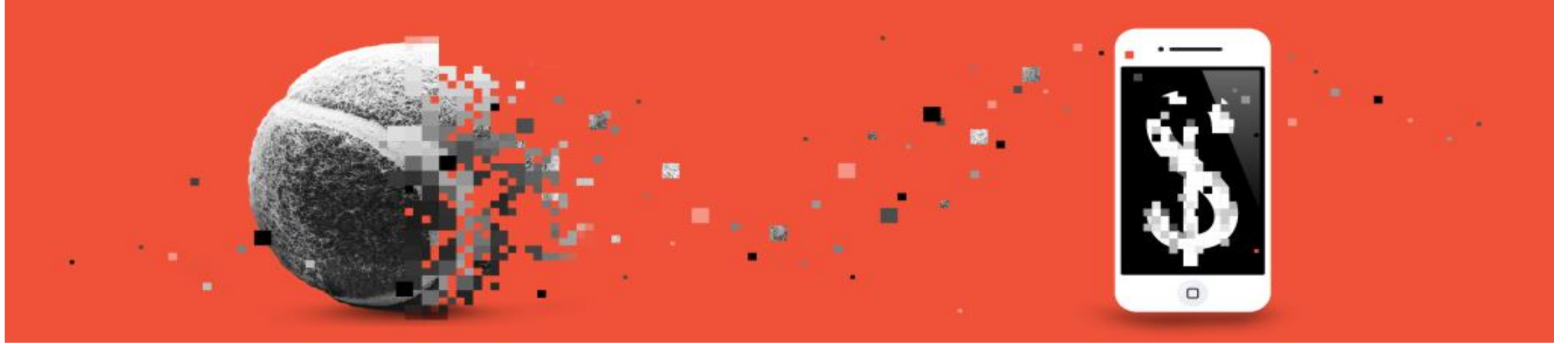

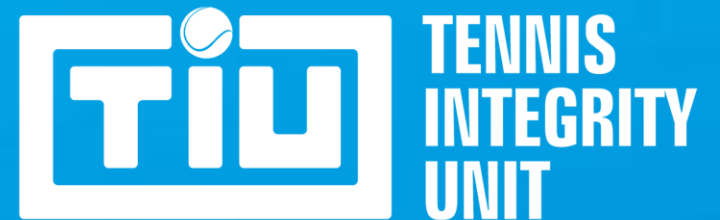


The TIU or Tennis Integrity Unit is the anti-corruption body covering all professional tennis around the world.

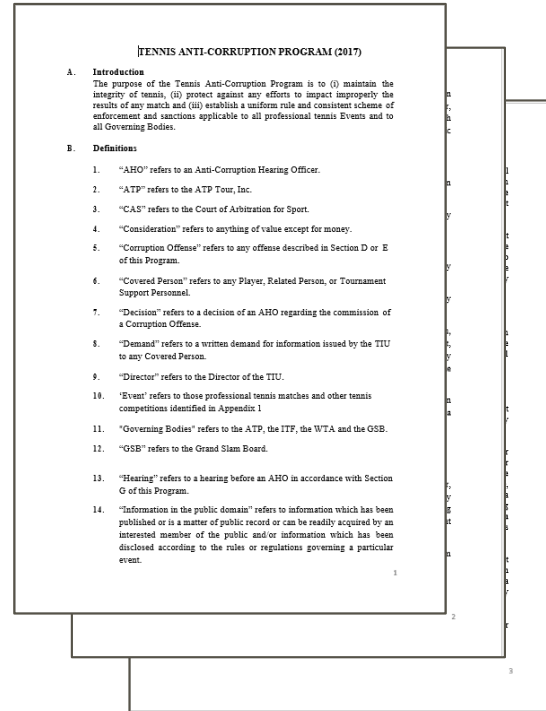

Tennis Anti-Corruption Programme (TACP)



TACP – Covered Persons



✓ **Players**

✓ **Related persons**

coach, trainer, therapist, physician, management representative, agent, family member, tournament guest, business associate and any person who receives accreditation at an event at your request

✓ **Tournament Support Personnel**

tournament director, officials, owner, operator, employee, agent, contractor and any other person who receives accreditation at an event



TACP – Prohibited Conduct



- ❌ **Betting** on any tennis match, at any time, anywhere in the world, and you must not assist others to do so
- ❌ **Fixing** the outcome or any aspect of a tennis match or event for any reason
- ❌ **Providing inside information** about a match for betting purposes
- ❌ **Betting companies** can't sponsor, employ or provide any other benefits to players
- ❌ **Accreditation** must not be sold and you must not accept any other benefit or consideration for it
- ❌ **Wildcards** must not be bought and you must not offer any other benefit or consideration for it

TACP Maximum Sanctions

Lifetime Ban
\$ 250 000 Fine



National & International Collaboration

- Regular active interactions with UK Gambling Commission (UKGC)
- Active member of the Sports Betting Integrity Forum (SBIF)
- 2019 TIU will co-Chair SBIF
- Present for UK signing of the Convention (December 2018)
- Meetings and interactions with a variety of National Platforms
- Meetings with Council of Europe and support for KCOOS
- Participation in conferences, events and sharing of good practice

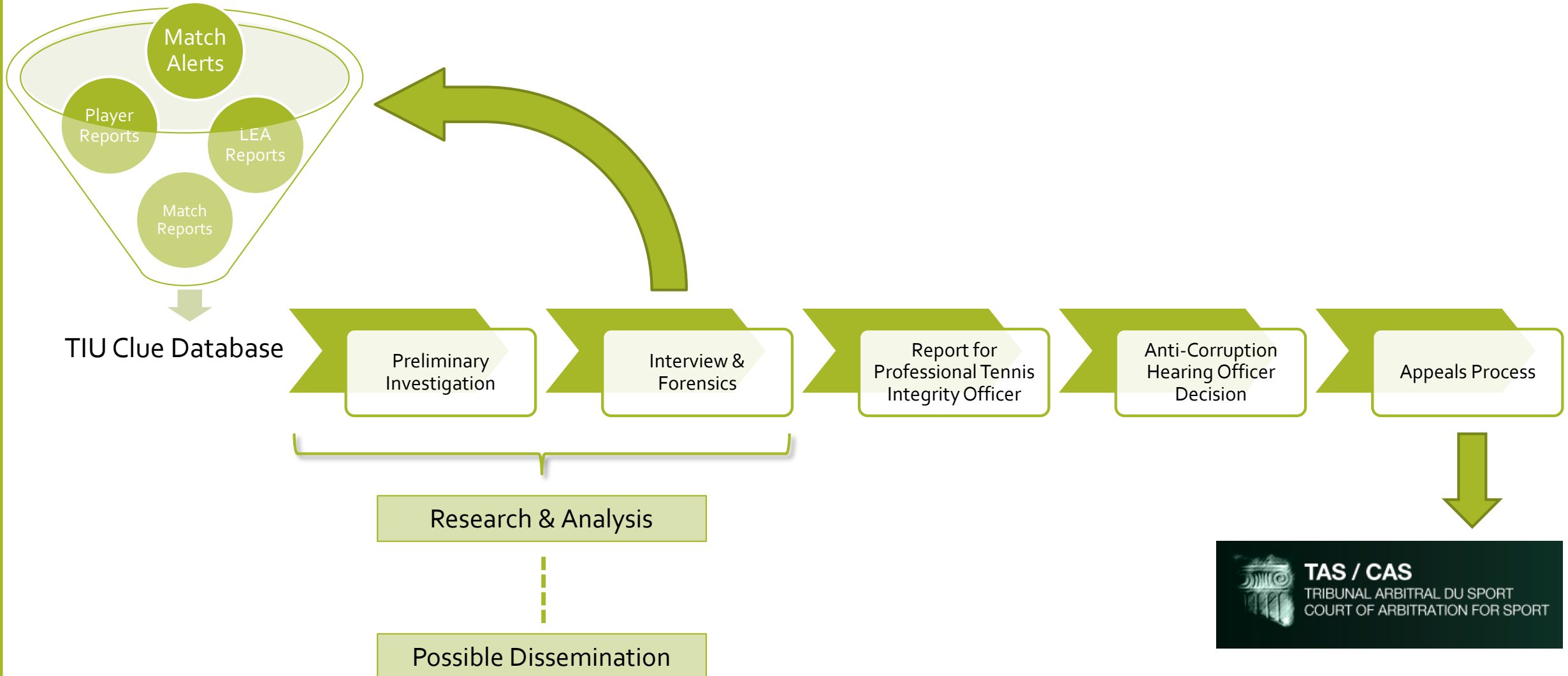

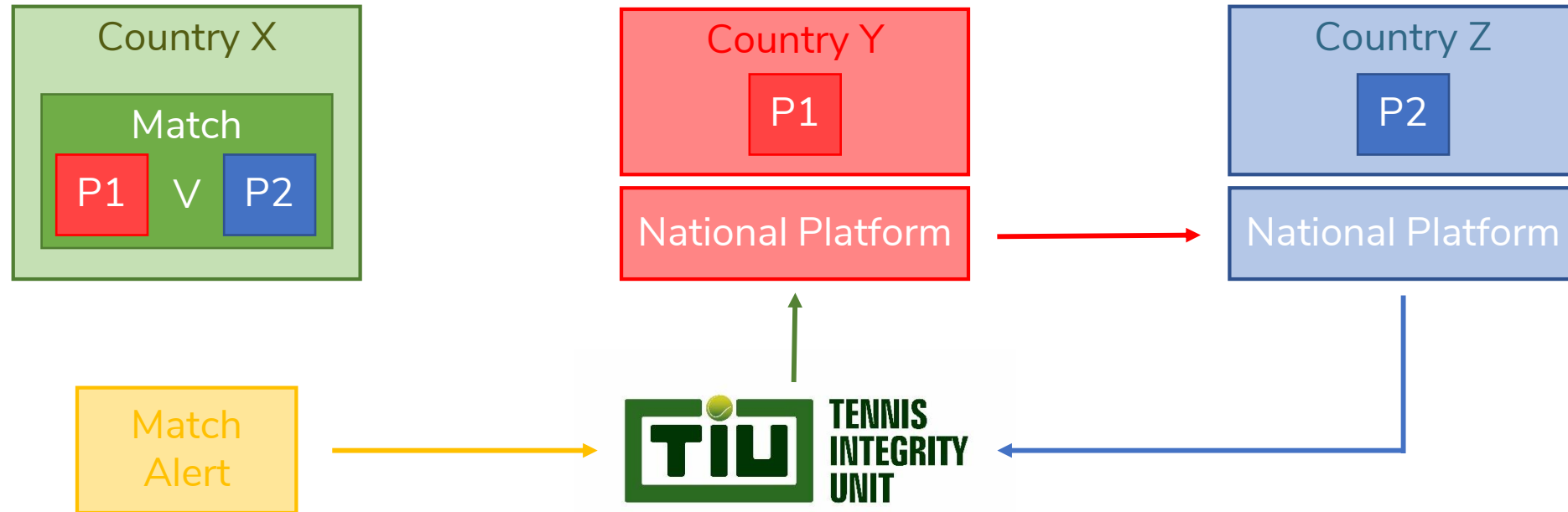

TIU Investigation Process





- **P2** subject of **Match Alerts** sent from European operator and global betting alert platform to **TIU**
- **TIU** contacts **National Platform Y**
- **National Platform Y** contacts **National Platform Z** regarding match and **P2**
- **National Platform Z** contacts **TIU** as **P2** is subject to live investigation and executive action in imminent
- **TIU** postpones activity to prevent cross agency activity
- December 2018: Investigations on-going
